



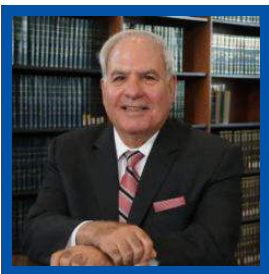
Eckell Sparks Attorneys Selected to the 2024 Pennsylvania Super Lawyers and Rising Stars Lists

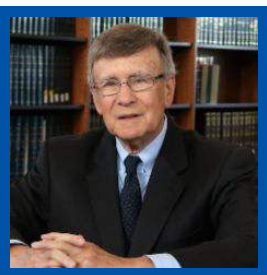
